Application of Fuel surcharge (YQ):-

1. The surcharge must be levied on all passengers per flight coupon booked on MK regardless of ticket stock.
2. The surcharge shall be applicable on any flight coupon with MK flight designator.
3. Discounts:
 - i. Child Fare: No discount
 - ii. Infant fare: Infant without a seat pays 10% of above surcharge
4. The surcharge must apply across the MK network to all fare types.
5. Must be collected at point of sale or ticket issuance / reissuance where applicable.
6. Fuel Surcharge must be shown as YQ in the Tax Box of the ticket.
7. The levy shall be in addition to all other charges.
8. The surcharge shall be applicable for sale in Mauritius and Worldwide.
9. The surcharge is non commissionable
